DECLARATION OF SUSTAINABLE DEVELOPMENT OF DCT GDAŃSK S.A.

DCT Gdansk S.A ("DCT") is an investment undertaking providing container and goods handling services and is a temporary stacking facility and a hub where containers are handled between different means of transport. The Company is located in Gdansk, which historically has been a significant transportation hub on the Amber Route. DCT is surrounded by areas of historical, tourist and natural (Nature 2000) importance, it makes the terminal's activity perfectly correspond with the history of the city, but also imposes on DCT an obligation of sustainable development.

The vision of DCT as the first-choice terminal located at the very heart of the Baltic Sea is a declaration made by the Company to global and local carriers. It defines our provision of favourable mechanisms and planing conditions within the transportation chain; optimizing costs and quality, comfort, safety and minimizing the environmental impact.

- execution of investment processes while maintaining bio-diversity, and when necessary, providing compensation measures.


The Company's Management Board declares to supervise the Company's activities and ensure their legal compliance.
